Dr. Chowdhury is also a Professor of Population and Family Health at the Mailman School of Public Health of Columbia University in New York, and serves on the boards of many international initiatives and journals. He is a co-recipient of the 'Innovator of the Year 2006' award given by the Marriott Business School of Brigham Young University in USA. He is the Coordinator of Education Watch and Member-Secretary of the Advisory Group for Health Watch in Bangladesh. Dr. Chowdhury is the Director of the recently established Centre for Health Systems Studies (CheSS) at the BRAC School of Public Health in Dhaka, Bangladesh.

Khaleda Islam, CARE-Bangladesh



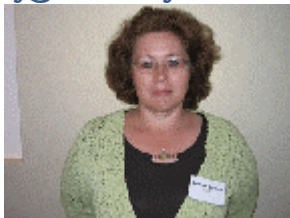

Samson Kironde, JSI, Uganda



Samson Kironde, Chief of Party for the Uganda Program for Human and Holistic Development (UPHOLD) has wide experience in project management, research and the monitoring and evaluation of public health programs. UPHOLD is a five-year \$96 million USAID funded five year program that aims at making a difference in the lives of Ugandans through supporting interventions in the fields of education, child and reproductive health as well as HIV/AIDS. This program is managed by a consortium of six partners led by JSI Research & Training Institute. As part of its work in health systems strengthening in Uganda, UPHOLD supports an annual survey in 29 districts that utilizes the Lot Quality Assurance Sampling (LQAS) survey methodology. LQAS is a simple, low-cost data collection methodology that has been institutionalized at district level and has increased the capacity of the lower levels of governance to carry out evidence-based planning and decision-making, which leads to better allocation of scarce resources.

Since 2003, UPHOLD has also trained and supported over 25,000 community volunteers in 19,000 villages in Uganda to have greater involvement in the fight against malaria by equipping them with the skills to carry out and monitor the home-based management of fever (HBMF) strategy. This has enabled over 1.6 million episodes of malaria in children under-five years to be promptly and effectively treated. Additionally, UPHOLD also supports the strengthening of the routine Health Management Information System (HMIS) in Uganda and during 2005 successfully negotiated with the Ministry of Health to incorporate into HMIS those indicators that monitor the HIV/AIDS epidemic more effectively.

Soyapi Lungu, Technical Cooperation Network, Malawi

Mr. Lungu's qualifications include degree in Public Administration, Certificate in Project Management and his specialty is human resources for health, in which he holds a masters degree. He has worked as a project administrative officer in the Population Health and Nutrition Project of the World Bank in Malawi, as Human Resources Planning Officer for the Ministry of Health in Malawi, and as a Management Development Consultant with the Malawi Institute of Management.
